I first experienced Wheelchair Rugby at the 2006 World Championships in Christchurch, New Zealand, subsequently joining the Board of Trustees in 2008 and becoming Chair in 2010. Since then I have been responsible for leading the Board and for ensuring that we meet all of our governance and legal requirements as a Limited Company and Charity. I chaired the Recruitment Panel in 2009 which recruited the current Chief Executive and am responsible for ensuring he gets the support and challenge to meet the annual objectives agreed by the Board. I am also a Member of the Governance and Finance Committee and I chair the WWRC15 Board and the GBWR Remuneration Committee.
